

ASSOCIATION CROQUET DOUBLES 2012

Monday nights.

Division 3 (32+) (Minimum aggregate 32)

For teams of four players on h/c 8+ but one player on 7 may be played provided the **aggregate handicap is not less than 32.**

CONDITIONS

1. Home team first named team.
2. 7 p.m. START. (If both teams are ready they may start earlier)
3. Five (5) minutes hit up is permitted provided the game will start on time.
4. Time limit 2.5 hours. **With turn after bell** 15 (C). Games must be doubled banked.
5. No drawn games but can have a drawn match. If scores are tied at the end of game then play must be continued until the next point is scored.
6. Fee of \$5 per player per game to be paid to home team
Match not starting due to some emergency e.g. failure of lights, bad weather or damaged courts match to be rescheduled by the Tournament Manager and played within 2 weeks. See Sect. 8.18 and 8.19 of Official Playing Regulations. Absence of regular team players is not an acceptable excuse.
